1. Travel Restrictions		
1.1 Incoming	From 16 March 2020 until 15 April 2020, entry into Kazakhstan is prohibited to foreigners (certain exceptions apply).	No entry from 15 March 2020. According to the decision of Republican Special Commission for preparing a program of measures to prevent the entry and spread of coronavirus into the territory of the Republic of Uzbekistan, all passenger (including aviation, railway and automobile) entry and departure from Uzbekistan will be restricted for 40 days, starting from 20 March 2020. The only exceptions are charter flights, which return citizens of Uzbekistan back.
1.2 Outgoing	From 16 March 2020 until 15 April, leaving Kazakhstan is prohibited to foreigners and citizens of Kazakhstan (certain exceptions apply).	No external travel from 15 March 2020. Restricted for 40 days since 20 March 2020.

2.1 Free Movement	Movement of people outside the city of Almaty and Nur-Sultan is prohibited (and people who are outside are not permitted to enter the city except for those in certain categories such as healthcare workers).	Traveling within the country (entry and exit), is prohibited. Major cities are closed for entrance/exit: Tashkent (from March 24), Namangan (from March 26), Samarkand (from March 27), Gulistan (from March 27), Andijan (from March 27)
2.2 Closures (public places, shops etc.)	Starting from 00:00 19 March 2020, Nur-Sultan and Almaty cities will be closed on quarantine. Schools, kindergartens, universities, shopping malls, theatres, exhibitions, fitness centres have been closed. Public events	Kindergartens, schools, universities, all non-state, extracurricular and pre-school educational institutions, all non-food markets, cinemas, theatres, disco clubs, spa salons, play yards, restaurants, cafes (except take-away services), karaoke, billiard rooms closed.

3.3 Banks	<p>The Agency on Regulation and Development of Financial Markets of RK (Agency) made a press release whereby penalties shall not be imposed for late payments on loans of individuals and legal entities caused by the emergency situation.</p> <p>Suspension of debt service obligations for 90 days for individual entrepreneurs, small and medium sized businesses if their financial condition has worsened due to the emergency situation.</p>	<p>Commercial banks are advised to soften loan repayment terms for enterprises negatively affected by the quarantine regime</p> <p>In particular, on the basis of appeals of borrowers - individuals and individual entrepreneurs it is recommended to extend the deadline for final payments on their loans until October 1, 2020.</p> <p>Besides, it is recommended to banks not to charge penalties on deferred credit debts and not to direct the collection on the loan collateral.</p> <p>Based on the situation related to the introduction of quarantine, in order to ensure distance, it is recommended that credit institutions take measures to create a system for remote consideration of applications for deferred payments on loans.</p>

To take measures to ensure liquidity of the banks for the total amount of 1 trillion soums. To defer till 5 October 2020 payments amounting to 5 trillion soums to commercial banks under the loans (without applying penalties) granted to tour operators, entities operating in hospitality sector, transportation, logistics and also legal entities facing difficulties due to limitations on foreign trade operations.
