

Often, the outcome of a tax audit depends significantly on the quality of interaction with the tax officers.

- Mediating discussions with the tax officers to ensure appropriate information disclosure;
- Vetting and reviewing all correspondence with the tax audit team;
- Ensuring full compliance with procedural rules and safeguarding your taxpayer rights throughout the audit process.

# 03. Tax Dispute Resolution

---

If a tax assessment decision has already been issued and you believe the assessment is overstated, we can assist you with the appeal against the decision, at all procedural stages.

Our services include:

- Reviewing all documents contained in the tax file;
- Preparing a robust litigation strategy on the merits of your case;
- Advising on and assisting with (i) the settlement of the tax assessment or (ii) measures to suspend the enforcement of the decision;
- Advising on available tax relief options (e.g., tax amnesty programs, deferred payment plans);
- Assisting with the suspension of enforcement measures initiated by tax authorities (e.g., garnishments, asset seizures).






